### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Daily observation of all animals to assess their health and well-being; Provided, however, That daily observation of animals may be accomplished by someone other than the attending veterinarian; and Provided, further, That a mechanism of direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian.

There was a yellow male lab in the Bread and Butter Barn, chip number 058-800-0608, that had a swollen right front paw that also had an area about 6cm x 3.5cm that was red and the skin was missing.

The facility needs to ensure that daily observations are conducted and in such a way so that the health and wellbeing of the animals is assessed so that animals with medical conditions can receive the appropriate adequate veterinary care to ensure their health and wellbeing.

Review daily observations with kennel staff and ensure that all animals are observed daily.

Correct immediately. This affects 1 animal indirectly.

Dogs and cats that are housed in the same primary enclosure must be compatible, with the following restrictions: Any dog or cat exhibiting a vicious or overly aggressive disposition must be housed separately.

During the inspection this inspector and the Owner cam upon 2 dogs fighting between two enclosures that housed 2 dogs each.

Aggressive dogs need to be housed separately and away from other dogs the aggressive dog may potentially harm to ensure the health and wellbeing of all the animals.
