The use of appropriate methods to prevent, control, diagnose, and treat diseases and injuries, and the availability of emergency, weekend, and holiday care.

Close-up inspection of a male Yorkie #097033348 revealed excessive buildup of dental tartar on the teeth.

Excessive dental tartar buildup on dog teeth can lead to severe periodontal disease. Periodontal disease can lead to tooth loss and/or severe systemic disease. These conditions will affect the health and well-being of these animals.

Provide adequate dental care for the dog that was identified with excessive tartar. Develop and maintain a preventative dental program for all the animals maintained at the facility.

ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

Daily observation of all animals to assess their health and well-being; Provided, however, That daily observation of animals may be accomplished by someone other than the attending veterinarian; and Provided, further, That a mechanism of direct and frequent communication is required so that timely and accurate information on problems of animal health, behavior, and well-being is conveyed to the attending veterinarian.

A yellow lab #021052347 and a bulldog #033261356 housed in primary enclosures next to each other were noted to be fighting between the fence partition. This was evident by a fresh laceration about 1.5 cm round in size on the right lip area of the face of the bulldog and the fresh scratches or teeth marks on the right lip area of the yellow lab.

Observation of animal behavior can indicate aggression and physical injuries. These behaviors may indicate that animals are experiencing conditions that affect their health and well-being.

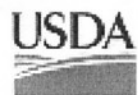

Develop and maintain a program of daily observations of all animals which includes an assessment of compatibility of animals between enclosures. Additionally provide medical treatment for the 2 affected animals.

PRIMARY ENCLOSURES.

Have no sharp points or edges that could injure the dogs and cats.

Pen number #250 housing 5 dogs in the Driveway Barn had an area of steel siding that was beginning to become jagged on the inside bottom edge of the shelter wall. Pen #249 housing 3 dogs also in the Driveway barn had an area under the doggie door outside of the shelter part that was becoming jagged.

Jagged areas cause a physical hazard that could seriously injure an animal should it come in contact with that area. This would affect the health and well-being of the dogs.

The two areas described were patched and repaired at the time of inspection.
