Animal Cruelty Chapter Added to MN Judges Criminal Benchbook

In early 2021, an Animal Cruelty Chapter (chapter 28) was added to the Minnesota Judges Criminal Benchbook, 7th Edition, published by Minnesota Continuing Legal Education (Minn CLE).

Animal Folks convened a team of four authors to write this chapter, focusing on Minnesota animal cruelty laws, legal precedent, and related issues.

The Minnesota Judges Criminal Benchbook is often used by judges and prosecutors while conducting legal research on Minnesota criminal laws and related issues.

This benchbook covers numerous topics, such as witnesses, sentencing, post-arrest procedures, search and seizure issues, discovery motions, competency and mental illness, sexual assault and abuse, domestic abuse



issues, driving while impaired, and more. Now a chapter specific to animal cruelty is available.

This project is part of Animal Folks' mission of sustainable system reform for the protection of animals.

PROGRAM GOALS AND ACCOMPLISHMENTS

PROGRAM 1: Animal Cruelty Research

GOAL: To research animal cruelty cases and issues pertaining to crimes against animals, and provide credible Minnesota-specific data to the public, agencies, and organizations upon request.

2021 Strategies and Actions

• Animal Cruelty Databank — An ongoing project for Animal Folks is the collection and maintenance of animal cruelty cases (convictions and dismissals) in Minnesota called the Animal Cruelty Databank. In 2021, thanks to the support of our donors, Animal Folks was able to format this data into a web-based system. This online structure will allow for more efficient coding of case details and related documents and to eventually allow access to this consolidated "animal cruelty case" data by the court system, including judges, prosecutors, and law enforcement. PROGRAM 2: Animal Law Resources

GOAL: To foster professionalism and competency by providing training, resources, and support to Minnesota authorities responsible for the enforcement of animal law.

2021 Strategies and Actions

- Animal Cruelty Training for Veterinary Students In 2021, Animal Folks continued providing animal cruelty training for senior veterinary students at the University of Minnesota. This is an ongoing partnership with the University. This training prepares students to become mandated reporters of animal cruelty once they are licensed.
- Animal Cruelty Training for Veterinarians For the sixth year, Animal Folks presented animal cruelty training for veterinarians at the Minnesota Veterinary Medical Association Annual Meeting. Ann Olson, Executive Director of Animal Folks, and Dr. Rachel Touroo, ASPCA Senior Director of Veterinary Forensics were speakers for this training.

PROGRAM 2: Animal Law Resources (continued)

• Animal Cruelty Chapter: MN Judges Criminal Benchbook In 2021, the Animal Cruelty Chapter was published in the Minnesota Judges Criminal Benchbook by Minnesota CLE.

Animal Folks is excited this information is now available to the courts and prosecutors. Animal Folks convened a team of four authors to write this chapter:



PRACTICE TIP

Minnesota Statutes section 343.21 subdivision 10 states that the court may consider any other cruelty related sentencing conditions not specifically listed in the section. The court should consider no ownership, custody, care (whether permanent or temporary), or control of any animals. The court could also consider prohibitions against employment at places that deal primarily with animals. Given the link between animal and human violence (see *infra* Section 2809.02), the court should also consider trauma assessments, trauma-informed services, or humane/empathy education for offenders.



PROGRAM 3: Legislative Action

GOAL: To lead and support state and local legislative efforts, including crafting of humane laws, lobbying, and advocacy, that protects animals and lays a foundation for systemic reform. *Creating or amending state and local laws can take years*. *Persistence is required; thanks for your support and involvement*.

2021 Strategies and Actions

- State of Minnesota: Companion Animal Board (CAB) Bill In 2021, Animal Folks continued lobbying the Companion Animal Board bill during the Minnesota legislative session. The Companion Animal Board will provide the necessary expertise to lead and respond to companion animal welfare issues statewide. Extensive advocacy was also conducted during the session and interim months, gathering thousands of Minnesota residents and over 25 organizations in support. Efforts continued to the 2022 legislative session. Learn more: www.mncab.org
- **City of Blaine: Humane Pet Store Ordinance** In 2021, Animal Folks, working with the "Go Humane, Blaine" coalition, lobbied the Blaine City Council to adopt a Humane Pet Store Ordinance. One of the largest pet stores that still buys from puppy mills is located in Blaine. Efforts continued to 2022. Learn more at: **www.gohumaneblaine.com**
- Winona County: Puppy Mill Initiative Working with residents in Winona County, Animal Folks launched a campaign in 2021 to ask the Winona County Board to ban further permitting of puppy mills in its county. Ann Olson, Executive Director of Animal Folks, testified before the county board multiple times. Animal Folks, with residents, also collected petitions in support of county action from hundreds of residents. These efforts continued to 2022. Learn more at: www.speakupwinonacounty.org

PROGRAM 4: Outreach & Communication

GOAL: To educate the public on animal law and cruelty issues, and enhance communication and cooperation between various stakeholders involved in the enforcement of animal law.

2021 Strategies and Actions

- **MN Continuing Legal Education (CLE) conference** A presentation about animal cruelty law was held on August 24, 2021 at the Minnesota Continuing Legal Education conference. Attended by legal professionals, the presentation was coordinated by Animal Folks and focused on the animal cruelty chapter added to the MN Judges Criminal Benchbook, published by MN CLE. The four authors who wrote the chapter were the speakers.
- Animal Law Section, MN State Bar Association A presentation about the Animal Cruelty Chapter for the MN Judges Benchbook was held on October 26, 2021 to the Animal Law Section of the MN State Bar Association.

PROGRAM 5: Criminal and Civil Justice

GOAL: To report suspected or known animal cruelty (or related crimes against animals) and provide input to criminal and civil cases throughout the legal process.

2021 Strategies and Actions



Moulton Chinchilla Ranch — Complaints for animal malteatment against Daniel Moulton, owner of Moulton Chinchilla Ranch, continued throughout 2021. Animal Folks had filed animal cruelty complaints against this facility in 2018 and 2019, showing violation of Minn. Statutes chapter 343; however, the Fillmore county attorney declined to charge.

The United States Department of Agriculture (USDA) had filed a complaint against this facility in 2018, citing multiple violations of the federal Animal Welfare Act for the period 2013-2017. Hearings for this federal complaint were held in 2021. Animal Folks obtained transcripts for the hearings held during two weeks.

Rupa Chilukuri, attorney with the Office of General Counsel at the USDA, stated during the 07-26-21 hearing: "Mr. Moulton's failure to provide this adequate veterinary care has resulted in immense avoidable suffering by the chinchillas. Animals had protruding growths and swelling on their bodies. They had wounds and missing limbs..." USDA inspectors (excerpt below) also provided testimony describing conditions found at the facility.

On October 8, 2021, the administrative law judge ordered Moulton's federal USDA license be revoked. Moulton was allowed to appeal but, months later (after filing extensions), chose not to appeal. No animals were confiscated.

The suffering of animals occurred in this breeding facility for years, illustrating why reform at local, state, and federal levels is critically needed for the protection of animals and proper enforcement of law.

It's the only facility that I've had to stop an inspection for because the ammonia levels in the facility were so bad that my eyes burned and my lungs burned and I had to exit the facility to breathe because I was afraid I was going to pass out. So I've used that as a tool as well to train employees on. And it's really one of the only facilities that I can think of that I've had bad dreams about afterwards. Specifically, one of the dead animals that I found at the facility one time kind of affected me hard and kind of gave me nightmares for a little while afterwards.
