In particular, you failed to provide adequate veterinary care for a chinchilla with a large growth protruding from the bottom of the animal's neck.)

• Primary conveyances (motor vehicle, rail, air, and marine). The animal cargo space of primary conveyances used in transporting live animals shall be designed and constructed to protect the health, and ensure the safety and comfort of the live animals contained therein at all times.

(Your employee transported a shipment of twelve chinchillas inside a vehicle that did not have adequate air circulation throughout the cargo space and had direct sunlight shining onto one of the transportation cages through a side window.)
