### RECORDS: DEALERS AND EXHIBITORS.

The facility has incomplete records. Records don't fully disclose animals' disposition for deaths and euthanized animals. The licensee stated that it was unknown that records of animal deaths/euthanized animals must be recorded. The facility had recently euthanized some animals under recommendation from the veterinarian. Some cages were marked and empty for euthanized animals however we could not completely ascertain the disposal of three animals that were in need of treatment on the February-11-2016 report. The licensee reports that they were euthanized. Without complete records, the facility may have problems tracking animal health and treatment progress and APHIS officials cannot accurately verify the disposition of the animals.

Correction: Maintain records complete from this day forward.

NOTE: This was a focused inspection on the Direct non-compliant items cited under 3.125(a) and 2.40 (b)(3) and the Direct and Non-direct items cited under 2.40(b)(2). Animals needing veterinary treatment were seen by the attending veterinarian and are receiving treatment.

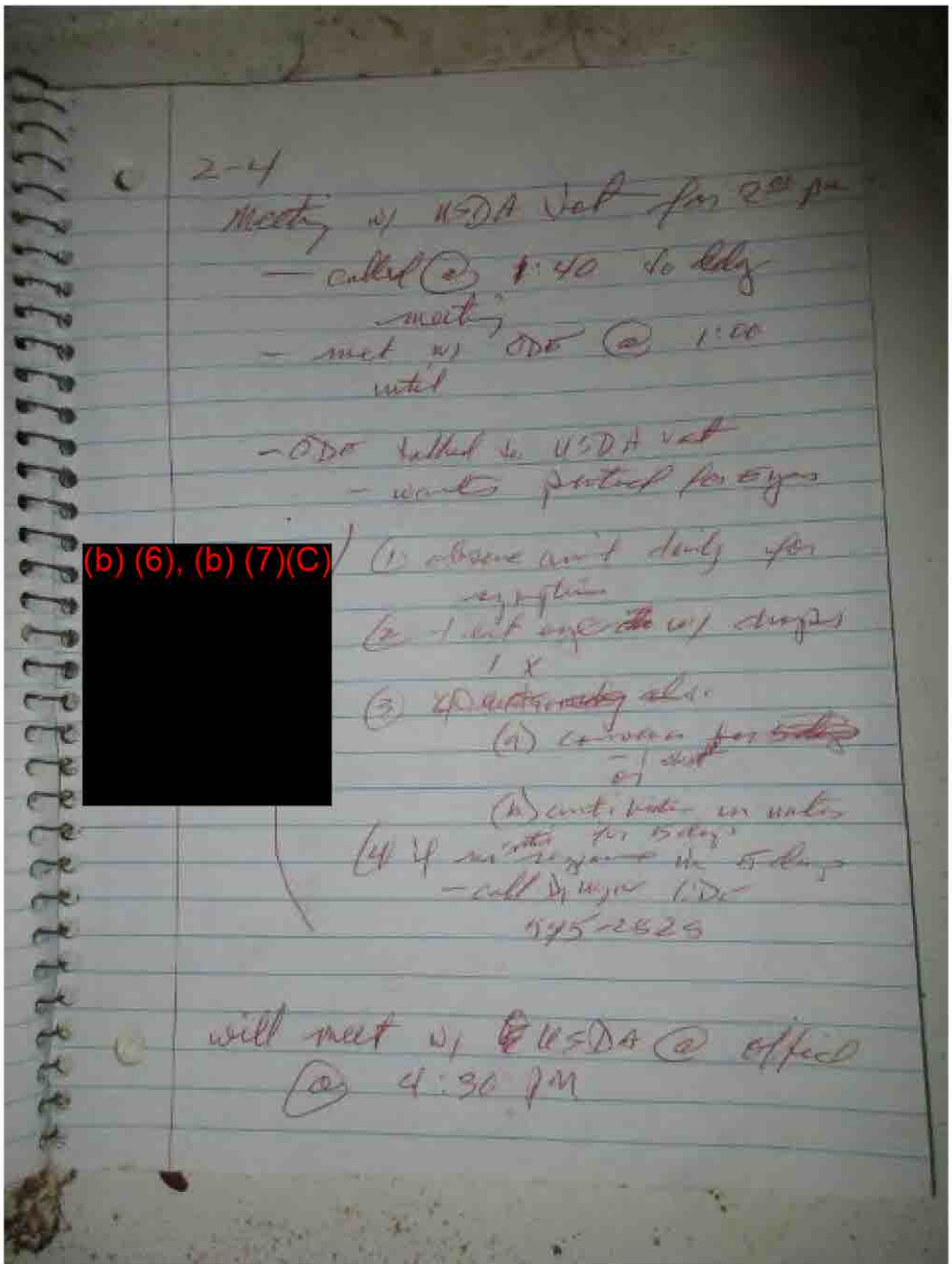

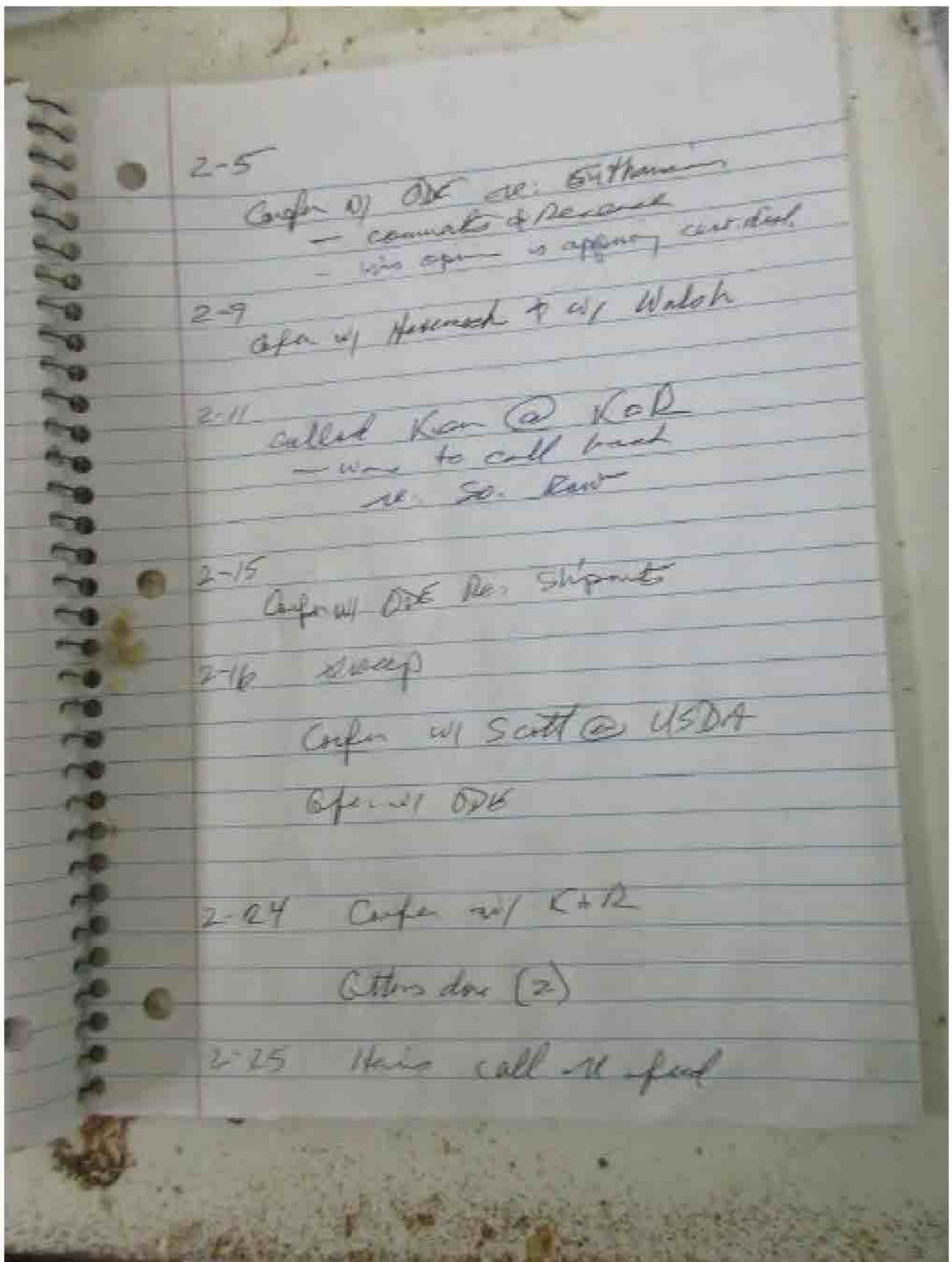
